#### 3.0 Introduction / Study Process

#### INTRODUCTION

Johnson Roberts Associates, Inc. (JRA) was retained by Leicester Public Schools (LPS) in April 2014 and was tasked with the preparation of a School Facility Master Plan to address the mid-term (+-10 years) facility needs of Leicester Public Schools.

This Facilities Master Plan addresses the scope, cost and feasibility of various repair, rehabilitation, expansion, and new construction options.

## EXISTING CONDITIONS DOCUMENTS

To assist in the preparation of the existing conditions documentation required for this master plan, the Johnson Roberts Associates team was provided with the following information and resources:

- Original Construction Drawings New Elementary School (currently Memorial School), by L. W. Briggs Associates – dated 1954;
- Original Construction Drawings Elementary School (currently Primary School), by O. E. Nault & Sons, Inc. dated 1972;
- Original Construction Drawings New High School, by Alderman & MacNeish – dated 1993;
- Memorial School Roof Replacement Drawings, by Nault Architects, Inc dated 2005;
- <u>Middle School Roof Replacement Drawings</u>, by Bradley Architects, Inc. dated 2011;
- <u>Town of Leicester ADA Transition Plan</u> by Kessler McGuinness & Associates, LLC – dated 2011.

#### **PROCESS**

In addition to the review of existing documents, drawings, and previously prepared reports, the Johnson Roberts Associates team visually reviewed and evaluated each school facility with critical attention paid to: compliance with current applicable life safety and accessibility codes; the determination of the potential life expectancy of existing materials and finishes; and a schedule for the proposed rehabilitation and/or expansion of the following (5) LPS owned facilities:

- Leicester Public Schools, Central Office Building
- Leicester Primary School
- Leicester Memorial School
- Leicester Middle School
- Leicester High School

During the course of multiple on-site inspections, all buildings were assessed for general safety, structural integrity, the status of operating systems, the conditions of existing equipment / fixtures / finishes, exterior envelope and roofs. The immediate sites, including vehicular access / circulation, pedestrian circulation, parking, as well as fields and athletic facilities were also reviewed and assessed. Based on the rough

dimensional confirmation of building layout and visual observations, the design team prepared new existing conditions floor layout plans for all five LPS facilities. The relevant existing conditions information, including floor layout plans, is documented in *Tabs 5-9* of this report.

### Meetings & Workshops The development of project Guiding Principles

During the design team's initial meeting with the Facilities Capital Committee (FCC) all attendees were asked to share individual aspirations and fears (regarding the upcoming project and process) with the overall group. All thoughts were documented and ultimately formed the basis of the Committee's work in the development and acceptance of the following project *Guiding Principles*:

Our facilities will: support and enable student-centered learning; function as community resources; provide access to technology (anywhere/anytime); be safe and secure; maximize energy efficiency and cost-effective sustainability; foster collaborations; inspire excellence in teaching and learning (both inside and outside) at all grade levels and abilities; be AWESOME.

Our master planning process will: make the LPS Vision Statement (Recognized by the community as its greatest asset, the Leicester Schools engage every child in rigorous and student-centered learning in a safe and technology-rich environment) a reality; allow us to develop a common understanding of the importance of comprehensive planning; investigate potential funding sources and partnerships; determine the best use and location of our facilities.

The FCC / JRA team met (6) times during the course of the development of this master plan. The individual meeting agendas are included at the end of this *Tab* 3.

In addition to regular meetings with the Facilities Capital Committee, the Johnson Roberts team, along with the Superintendent of Schools, conducted the following project visioning sessions/workshops:

- An initial project visioning session with the LPS elementary school staff;
- An initial project visioning session with the LPS middle/high school staff;
- An initial project visioning session with the overall LPS community;
- An educational programming/visioning workshop with the LPS Administrative Cabinet;
- An educational programming/visioning workshop with the entire grades K-12 school staff;
- A project update/preferred options workshop with representatives of the Board of Selectmen, School Committee, Finance Advisory Board, and Town Administrator.

#### 3.0 Introduction / Study Process

#### Future Enrollment Assumptions / Confirmation

In order to facilitate the preparation of a grades PK-12 educational space needs program and understand it's impact on physical space, a planned enrollment of 1,680 students (grades PK-12), was established. A description of this process, along with supporting information, is included within **Tab 4**.

#### **Educational Programming**

Once the planned enrollment was established, the Johnson Roberts team developed a series of *Preliminary Educational Programs* for various grade alignment options. All programs were reviewed with the Superintendent of Schools, the Senior Administrative Team (including building Principals), as well as with the entire grades PK-12 faculty. Following extensive review and discussion, it was agreed that (2) grade configuration options (including a 'three building option' as well as a 'two building option') would be 'tested' against the existing building infrastructure. Please refer to *Tab 4* for additional information.

#### **Preliminary Options**

A baseline 'Repairs Only' Option, which summarizes the findings of the existing conditions analysis, was developed for each facility. This Option determined that in order to extend the projected useful life of each of the (5) LPS facilities for an additional 20-25 years (through the year +-2039), the Town of Leicester could anticipate spending +-\$52.0 to \$66.5 mil in upgrades and improvements. Please refer to **Tabs 5-9** for additional information and documentation,

A series of (3) Preliminary Layout Options, which 'tested' the various <u>educational</u> <u>programs</u> against the <u>space available</u> within the existing overall building stock, were developed. Each Option was developed in accordance with the preferred *Preliminary Educational Programs* and included holistic facility and educational improvements, modifications, and/or expansions. A costing analysis, which notes <u>potential</u> reimbursable costs from the Massachusetts School Building Authority (MSBA), was developed for each Option. Following an 'apples-to-apples' comparison of the (3) Preliminary Layout Options, the FCC voted to explore the further development of (2) Options. Specific layout and costing information regarding the (3) *Preliminary Options* as well as the *Repairs Only* baseline option is included within *Tab 10*.

#### **Preferred Options**

In addition to the 'REPAIRS ONLY' baseline option, the Committee narrowed down options for further (future) review to: OPTION 1, three buildings, (a rehabilitation/expansion of the existing Primary School for grades PK-5, a new Middle School on the HS campus for grades 6-8, and a rehabilitation of the existing High School for grades 9-12 and Central Administration) with a potential NET cost of +-\$60.0 mil - \$76.5 mil and OPTION 2, two buildings (a new facility on the HS campus for grades PK-5 and a rehabilitation/expansion of the existing High School for grades 6-12 and Central Administration) with a potential NET cost of +-\$61.0 mil - \$78.5 mil.
